

**ORDINANCE NO. O-2016-46**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, DECLARING THE RESULTS OF AN ELECTION HELD IN THE CITY OF TYLER, TEXAS, ON THE 7<sup>th</sup> DAY OF MAY, 2016, FOR THE ELECTION OF THE MAYOR AT LARGE AND CITY COUNCILMEMBER FOR DISTRICT NO. 6 AND AFFIRMING THE CANCELLATION OF THE ELECTION AND DESIGNATION OF UNOPPOSED WINNERS FOR CITY COUNCILMEMBER DISTRICT NO. 2 AND CITY COUNCILMEMBER DISTRICT NO. 4., DECLARING THE WINNERS, AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, on the 18<sup>th</sup> day of May, 2016, the City Council of the City of Tyler, Texas, at a meeting duly called for the purpose, canvassed the returns of the City Council Election held on the 7<sup>th</sup> day of May, 2016, in the City of Tyler, for the election of Mayor at Large and a City Councilmember for District No. 6, for the City of Tyler, Texas, and it appearing as a result of such canvass that the following named persons received the following number of votes for Mayor at Large, and City Councilmember, District No. 6:

**Mayor At Large**

Martin Heines	2,725 Votes
Joel Rando	100 Votes
Michael Williams	132 Votes

**District No. 6, For City Councilmember**

John Nix	916 Votes
Clarke Hampe	532 Votes

**WHEREAS**, the City Clerk has certified in writing that the candidates for District No. 2 and District No. 4 were unopposed and that no write-in candidates had filed to be placed on the list of write-in candidates for that place; and

**WHEREAS**, Texas Election Code Sections 2.051 through 2.054 authorize the City Council to declare the unopposed candidates elected to office and cancel the unneeded elections;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:**

**PART 1:** That Martin Heines be and is hereby declared the duly elected Mayor At Large to serve for a two-year term of office.

**PART 2:** That Darryl Bowdre be and is hereby declared the duly elected City Councilmember for District No. 2, to serve for a two-year term of office.

**PART 3:** That Don Warren be and is hereby declared the duly elected City Councilmember for District No. 4, to serve for a two-year term of office.


**PART 4:** That John Nix be and is hereby declared the duly elected City Councilmember for District No. 6, to serve for a two-year term of office.

**PART 5:** That the City Council Election for District No. 2, and District No. 4, scheduled for May 7, 2016, was cancelled and such cancellation is hereby affirmed.


**PART 6:** That the above named Mayor At Large and City Councilmembers for District No. 6 shall be sworn into office in the same manner provided for candidates that would have been elected at the election, and shall each serve for a two-year term of office.

**PART 5:** That this ordinance shall take effect immediately upon its adoption.
