

ORDINANCE NO. 0-2016-95

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, AMENDING THE BUDGET FOR FISCAL YEAR 2015-2016 AUTHORIZING THE APPROPRIATION OF FUNDS FOR THE FIFTY PERCENT LOCAL SHARE REQUIRED FOR THE 2015/2016 TEXAS DEPARTMENT OF TRANSPORTATION RAMP GRANT; PROVIDING A SEVERABILITY CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, The Texas Department of Transportation has offered a \$50,000 RAMP Grant for the maintenance of Tyler Pounds Regional Airport; and

WHEREAS, it is the intent of this grant to not supplant local funds normally utilized for airport maintenance, and that any state financial assistance offered under this grant be in addition to those local funds normally dedicated for airport maintenance; and

WHEREAS, this budget amendment will provide funding for the fifty percent local share required by this grant;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

PART 1: That the following line item accounts as approved in the budget for fiscal year 2015-2016 shall be amended to read as follows:
