

ORDINANCE NO. O-2013-18

AN ORDINANCE APPROVING THE APPOINTMENT OF A CHAIRPERSON AND DIRECTORS FOR POSITION NUMBERS ONE THROUGH SIX TO THE BOARD OF DIRECTORS FOR REINVESTMENT ZONE NO. 1; APPROVING ADDITIONAL APPOINTMENTS BY SMITH COUNTY, TYLER JUNIOR COLLEGE AND TYLER INDEPENDENT SCHOOL DISTRICT FOR POSITION NUMBERS SEVEN THROUGH NINE TO THE BOARD OF DIRECTORS FOR REINVESTMENT ZONE NO. 1; AND SETTING FORTH OTHER PROVISIONS RELATED THERETO; PROVIDING A SEVERABILITY CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City Council has adopted Ordinance No. 0-1998-100 designating a contiguous area within the City of Tyler, Texas as Reinvestment Zone Number One ("Zone No. 1") under the provisions of Chapter 311 of the Texas Tax Code; and

WHEREAS, Ordinance No. 0-95-12 established Board of Directors for Zone No. 1 which shall consist of nine (9) members, being Positions One (1) through Six (6), to be nominated and appointed by the Mayor, Position Seven (7) being appointed by the County of Smith, Position Eight (8) being appointed by the Tyler Independent School District, Position Nine (9) being appointed by the Tyler Junior College District, with one of the said members being nominated and appointed as the Chairperson by the Mayor, and all said appointments approved by the City Council; and

WHEREAS, the City Council hereby approves the nomination and appointment of the duly qualified persons listed below to Chairperson and to Positions 1 through 9 on the Board of Directors for Zone No. 1 for the terms as described; and

WHEREAS, the City Council hereby approves the nomination and appointment by Smith County, Tyler Independent School District and Tyler Junior College District of the duly qualified persons listed below to Positions 7 and 9 on the Board of Directors for Zone No. 1 for the terms as described below;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

PART 1. Findings

(a) That the facts and recitations contained in the preamble of this Ordinance are hereby found and declared to be true and correct and are adopted as part of this Ordinance for all purposes.

(b) It is hereby found and declared that all of the nominees listed in Part 2 are either (i) qualified voters of the City or (ii) at least 18 years of age and own real property in the Zone, and /or (iii) are designated representatives of property owners in the Zone.

PART 2. Consent To and Approval of Appointment to the Board of Directors of Reinvestment Zone Number One

That the City Council does hereby consent to and approve of the appointment to the Board of Directors of Reinvestment Zone Number One, City of Tyler, Texas, of the duly qualified persons to Chairperson and Director Positions 1 through 9 as described below:

PART 3. Open Meetings

It is hereby found, determined and declared that a sufficient written notice of the date, hour, place and subject of the meeting of the City Council at which this Ordinance was adopted was posted at a place convenient and rapidly accessible at all times to the general public at the City Hall of the City for the time required by law preceding its meeting, as required by the Open Meetings Law, Texas Government Code, Ch. 551, as amended, and that this meeting has been open to the public as required by law at all times during which this Ordinance and the subject matter hereof has been discussed, considered and formally acted upon. The City Council further ratifies, approves and confirms such written notice and the contents and posting thereof.

PART 4. Severability Should any section, subsection, sentence, provision, clause or phrase be held to be invalid for any reason, such holding shall not render invalid any other section, subsection, sentence, provision, clause or phrase of this ordinance and same are deemed severable for this purpose.

PART 5. This Ordinance shall be effective on the date of passage and approval by the City Council, in accordance with the Tyler City Charter.

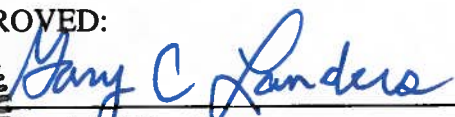
