

**ORDINANCE NO. 0-2013-6**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER,  
TEXAS, AMENDING THE BUDGET FOR FISCAL YEAR 2012-2013.  
AUTHORIZING THE APPROPRIATION OF FUNDS FOR PROJECTS  
AND PURCHASES APPROVED IN THE 2011-2012 BUDGET BUT NOT  
PURCHASED OR COMPLETED IN THAT FISCAL YEAR; AND  
ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, during fiscal year 2011-2012, various purchases and projects were started but were not completed; and

**WHEREAS**, various equipment, motor vehicle and construction projects were planned but not completed during the fiscal year; and

**WHEREAS**, this budget amendment will provide funding for completion of these purchases and projects during the current fiscal year;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:**




**PART 4:** That this ordinance shall take effect immediately upon approval.
