

ORDINANCE NO. 0-2013-26

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER,
TEXAS, CANCELING THE CITY COUNCIL SPECIAL CALLED
ELECTION FOR DISTRICT SIX, SCHEDULED FOR MAY 11, 2013, AND
DECLARING THE UNOPPOSED CANDIDATE FOR SINGLE MEMBER
DISTRICT SIX ELECTED TO OFFICE.**

WHEREAS, a City Council Special Election is currently scheduled for May 11, 2013; and

WHEREAS, no proposition is to appear on the ballot for the May 11, 2013, special election for Districts Six; and

WHEREAS, the City Clerk of the City of Tyler has certified in writing that the candidate for City Council District 6 is unopposed and that no write-in candidates have filed to be placed on the list of write-in candidates; and

WHEREAS, Texas Election Code Sections 2.051 through 2.054 authorize the City Council to declare each unopposed candidate elected to office and to cancel the special election;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

PART 1. That John Nix, is hereby declared the duly elected City Council member for District Six, to serve for a two-year term of office, to begin May 11, 2013.

PART 2. That the City Council Special Election for District Six scheduled for May 11, 2013, is hereby canceled.

PART 3. That a copy of this ordinance shall be posted on May 11, 2013 at each polling place that would have been used in the special election, and said notice shall be in both English and Spanish.

PART 4. That after May 11, 2013, a certificate of special election shall be issued to the above named unopposed candidate in the same manner as provided for the candidate elected at the special election.

PART 5. That upon issuance of a certificate of election, the above named unopposed candidate shall be sworn into office in the same manner provided for the candidate elected at the special election.

PART 6: That this ordinance shall take effect immediately upon its adoption.
