

**ORDINANCE NO. O-2011-35**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER,  
TEXAS, AMENDING THE BUDGET FOR FISCAL YEAR 2010-2011  
AUTHORIZING THE ACCEPTANCE OF GRANT FUNDING THROUGH  
THE FAMILY SELF SUFFICIENCY PROGRAM (FSS) FOR ONE (1) FSS  
COORDINATOR POSITION TO ENHANCE THE HOUSING EFFORTS  
OF THE NEIGHBORHOOD SERVICES DEPARTMENT; AND  
ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, Family self-sufficiency (FSS) is a HUD program that encourages communities to develop local strategies to help voucher families obtain employment that will lead to economic independence and self-sufficiency; and

**WHEREAS**, public housing agencies (PHAs) work with welfare agencies, schools, businesses, and other local partners to develop a comprehensive program that gives participating FSS family members the skills and experience to enable them to obtain employment that pays a living wage; and

**WHEREAS**, on December 2, 2010, Staff submitted a proposal to HUD to administer the Family Self-Sufficiency Program and funding for a FSS Coordinator position (salaries & benefits only); and

**WHEREAS**, on April 13, 2011 and on April 18, 2011, Staff received official notification that the City of Tyler had been selected to receive \$49,564 for the Fiscal Year 2010 Housing Choice Vouch Family Self Sufficiency Program Coordinator Salaries to support one (1) position.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE  
CITY OF TYLER, TEXAS:**

**PART 1:** That the following line item accounts as approved in the budget for fiscal year 2010-2011 shall be amended to read as follows:
