**WHEREAS**, notice of City meetings is regularly and routinely posted at least seventy-two (72) hours prior to the meeting in accordance with Texas Gov't Code Sec. 551.043; and

**WHEREAS**, notice for a meeting of the Tyler City Council was previously posted for the Tyler City Council to conduct a meeting in the City Council Chambers, Second Floor, City Hall, 212 N. Bonner, Tyler, Texas, at 9:00 a.m. on Wednesday, August 23, 2023; and

**WHEREAS**, due to unforeseen circumstances, notice was not timely posted for the Tyler City Council to attend a City Boards and Commissions Training Session to be held immediately after the posted City Council Meeting to held at 9:00 a.m. on Wednesday, August 23, 2023, City Hall, 212, N. Bonner, Tyler, Texas; and

**WHEREAS**, information was previously sent to Council members and persons planning to attend the training session; and

**WHEREAS**, it would create a severe hardship to persons planning to attend this training session if the scheduled meeting was not held; and

**WHEREAS**, it is important for the City Council to receive this regular City Boards and Commission training in order to meet scheduled dates for appointment or re-appointment to the Boards, as set forth by Ordinance and/or as otherwise scheduled by the City Council; and

**WHEREAS**, although this notice for a Boards and Commission Training Session of the Tyler City Council Gathering was not posted prior to 72 hours of the event, it would result in unnecessary public inconvenience so there is an urgent public necessity that this posting be made and the training proceed as originally planned and publicized; and

**WHEREAS**, Texas Gov't Code Sec. 551.045 provides that in an emergency or when there is an urgent public necessity, the notice of a meeting or the supplemental notice of a subject added as an item to the agenda for a meeting for which notice has been posted in accordance with Texas Gov't Code Chapter 551, Subchapter C., is sufficient if it is posted at least one hour before the meeting is convened;
