M-1 Request that the City Council consider the designation of Reinvestment Zone Number Fourteen (Hiland Dairy), City of Tyler, Texas, for industrial tax abatement, consider adoption of a Resolution nominating Hiland Dairy Foods, Inc. for designation as an Enterprise Project under the Texas Enterprise Zone Act, Texas Government Code Chapter 2303, and authorize the City Manager to finalize and enter into a tax abatement agreement with Hiland Dairy Foods, Inc. and to sign all documents necessary to implement the tax abatement agreement.
