

**ORDINANCE NO. O-2025-8**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, AMENDING THE BUDGET FOR FISCAL YEAR 2024-2025 AUTHORIZING THE APPROPRIATION OF FUNDS FOR PROJECTS AND PURCHASES APPROVED IN THE 2023-2024 BUDGET BUT NOT PURCHASED OR COMPLETED IN THAT FISCAL YEAR; PROVIDING A SEVERABILITY CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, during fiscal year 2023-2024, various purchases and projects were started but were not completed; and

**WHEREAS**, various equipment, motor vehicle and construction projects were planned but not completed during the fiscal year; and

**WHEREAS**, this budget amendment will provide funding for completion of these purchases and projects during the current fiscal year;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:**

**PART 1:** That the following line item accounts as approved in the budget for fiscal year 2024-2025 shall be amended to read as follows:


**PART 2:** That the City Clerk is hereby directed to file a copy of this budget amendment as required by state law.

**PART 5:** That this ordinance shall take effect immediately upon approval.
