

**RESOLUTION NO. R-2025-11**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, AUTHORIZING SUBMISSION OF AN APPLICATION BY THE TYLER POLICE DEPARTMENT FOR, AND ACCEPTANCE OF, FUNDING THROUGH THE OFFICE OF THE GOVERNOR'S (OOG) HOMELAND SECURITY GRANTS DIVISION (HSGD) FOR GRANT FUNDING THROUGH THE STATE HOMELAND SECURITY PROGRAM (SHSP), AS MANAGED BY THE EAST TEXAS COUNCIL OF GOVERNMENTS, TO FUND THE PURCHASE OF EQUIPMENT INTENDED TO SUPPORT LOCAL PREPAREDNESS FOR LAW ENFORCEMENT TERRORISM PREVENTION ACTIVITIES (LETPA); DESIGNATING THE CITY'S AUTHORIZED OFFICIAL; AUTHORIZING ALL NECESSARY ACTIONS RELATED TO ACCEPTANCE AND USE OF THE GRANT; AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, it is the intent of the City Council to promote the public health, safety, and welfare; and

**WHEREAS**, the Office of the Governor's (OOG's) Homeland Security Grants Division (HSGD) currently serves as the State Administrative Agency (SAA) for the State of Texas' State Homeland Security Program (SHSP), which provides grant funding used to support programs and projects aimed at maintaining and/or enhancing emergency preparedness and response capabilities; and

**WHEREAS**, The City Council of the City of Tyler finds it in the best interest of the citizens of Tyler that the established State Homeland Security Program (SHSP) funding be utilized for the 2025-2026 year; and

**WHEREAS**, The City Council agrees that in the event of loss or misuse of the State Homeland Security Program funds, the Tyler City Council assures that the funds will be returned in full to the Office of the Governor; and

**WHEREAS**, it is considered to be in the public interest to obtain and use grant funds for the above public purpose(s); and

**WHEREAS**, The City Council designates the City Manager as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter, terminate, and/or take all necessary actions related to the grant and use of funds under the grant on behalf of the applicant agency; and

**WHEREAS**, the Office of the Governor's Homeland Security Grants Division will fund the proposed equipment in the amount of \$17,723.00 for one year, after which additional funding must be reapplied for;

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS;**

**PART 1:** That the City Council of the City of Tyler approves grant application #4988102/**Robot accessories SHSP FY25.26**, for and acceptance of State Homeland Security Program (SHSP) funding through the Office of the Governor (OOG), not to exceed \$17,723.00, to assist in funding

additional accessories (quick-release FLIR camera and small portable screen) for a small tactical robot (awarded in FY25 SHSP grant), intended to support the grant program purpose, for the Tyler Police Department.

**PART 2:** That the filing of the grant application, and all actions taken in connection therewith, by City Staff, is hereby authorized and affirmed.

**PART 3:** That the City Council hereby resolves and affirms that the City of Tyler has legal authority to apply for the grant and to carry out the proposed project(s).

**PART 4:** That the City Council hereby resolves and affirms the City of Tyler's intent to comply with all of the assurances set forth in the grant agreement and all laws, regulations, and circulars incorporated by reference in the grant agreement.

**PART 5:** That the City Manager is hereby designated as the City of Tyler's authorized official, and is hereby authorized to apply for, reject, alter, terminate, and/or take all necessary actions related to the grant and use of funds thereunder on behalf of the City of Tyler.

**PART 6:** That the City Manager of the City of Tyler, or designee, is hereby authorized and directed to provide such additional information as may be required by the State of Texas Office of the Governor (OOG) State Homeland Security Program (SHSP).


**PART 7:** That the City Council agrees that in the event of loss or misuse of grant funds, the City will return all such grant funds to the State of Texas Office of the Governor.
