

## **RESOLUTION NO. R-2025-23**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, ORDERING AND GIVING NOTICE OF AN ELECTION TO BE HELD IN THE CITY OF TYLER ON THE 3RD DAY OF MAY, 2025, BY AMENDING THE POLLING LOCATIONS FOR A PREVIOUSLY CALLED ELECTION TO FILL THE OFFICE OF TYLER CITY COUNCIL MEMBER DISTRICTS NUMBER 1, NUMBER 3 AND DISTRICT NUMBER 5; MAKING PROVISIONS FOR AND RESOLVING OTHER MATTERS INCIDENT AND RELATED TO SUCH ELECTION: REDUCING THE TOTAL NUMBER OF VOTING LOCATIONS RELATED THERETO; AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, it is now necessary to hold an election to fill expiring terms of the Tyler City Council Member, and such election is required by law to be held the first Saturday in May; and

**WHEREAS**, on February 12, 2025, the Tyler City Council adopted Resolution No. R-2025-13, calling an Election for May 3, 2025 to fill the offices of the City Councilmembers for Single Member District 1, Single Member District 3 and Single Member District 5 on the Tyler City Council; and

**WHEREAS**, on February 26, 2025, the Tyler City Council adopted Ordinance No. 0-2025-11, canceling the Election for Single Member District 5 scheduled for May 3, 2025, declaring the unopposed candidate for Single Member District 5 elected to office, leaving Tyler City Council Districts No. 1 and 3, and

**WHEREAS**, the original number of polling places referenced in Resolution No. R-2025-13 is no longer necessary due to the reduced number of Tyler Councilmember District seats up for election;

**WHEREAS**, it is now necessary to give notice of an election and reduce the number of voting locations for the May 3, 2025 election for remaining Tyler City Councilmember Districts 1 and 3;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:**

**PART 1:** That the voting places originally approved in Resolution No. R-2025-13 at the February 12, 2025 meeting shall be reduced as set forth below, as related to the regular Election on May 3, 2025, to fill the offices of Tyler City Council Member Districts Number 1 and Council Member District Number 3:

**General Election–May 3, 2025** (*Elección general – 3 de Mayo del 2025*)

**Notice of Election** (*Aviso de elección*)

**Notice of Early Voting Polling Places** (*Aviso de Lugares de Votación Anticipada*)
