

**RESOLUTION NO. R-2025-36**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, SUPPORTING AND AUTHORIZING AND DIRECTING THE CITY MANAGER OR THE CITY MANAGER'S DESIGNEES TO PARTICIPATE WITH THE TEXAS DEPARTMENT OF TRANSPORTATION IN THE DESIGN OF A SAFETY PROJECT ON STATE HIGHWAY (SH) 110 FROM NORTH OF ABERDEEN DRIVE TO COUNTY ROAD 2123; UNDERSTANDING THE SAFETY AND MOBILITY IMPROVEMENTS MAY INCLUDE, BUT ARE NOT LIMITED TO, A RAISED MEDIAN, ACCESS MANAGEMENT CONTROL, ILLUMINATION, AND TRAFFIC SIGNALIZATION; FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS RESOLUTION WAS APPROVED COMPLIED WITH THE TEXAS OPEN MEETINGS ACT; AND DECLARING AN EFFECTIVE DATE.**

**WHEREAS,** it is the intent of the Tyler City Council to protect the public health, safety, and welfare; and,

**WHEREAS,** Transportation Code, Chapters 201 and 221, authorize the State of Texas (the "State") to lay out, construct, maintain, and operate a system of streets, roads, and highways that comprise the State Highway System; and,

**WHEREAS,** the Texas Department of Transportation has identified a need for safety and mobility enhancements on SH 110 from north of Aberdeen Drive (inside the City Limits) to County Road 2123 (outside of the City Limits) (hereinafter referred to as the "Project"); and,

**WHEREAS,** the Texas Department of Transportation desires to design safety improvements on the Project; and,

**WHEREAS,** the Project design and construction costs will be funded through and by the Texas Department of Transportation; and,

**WHEREAS,** the City of Tyler is not responsible for committing funds towards the development and construction of the Project; and,

**WHEREAS,** the Tyler City Council finds it to be in the best interest of the City to support the project for increased safety on SH 110 entering and exiting the City of Tyler.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:**

Section 1. That the City of Tyler supports a raised median project on SH 110 from just north of Aberdeen Drive to County Road 2123 to enhance safety.

Section 2. That the City of Tyler understands the project will be developed by a design process through which the City will be an active partner and participant with the Texas Department of Transportation in order to address safety, mobility, and access needs for all users along the corridor.


Section 3. That the City of Tyler understands the safety improvements may include, but are not limited to, a raised median, access management control, illumination, and traffic signalization.

Section 4. That the City Manager or the City Manager's designee and any other official of the City as shall be required are hereby authorized and directed to participate with the Texas Department of Transportation in the development of this project.

Section 5. That the meeting at which this Resolution was approved was, in all things, conducted in strict compliance with the Texas Open Meetings Act, Texas Government Code Chapter 551.

Section 6. That this Resolution shall become effective immediately upon adoption.
