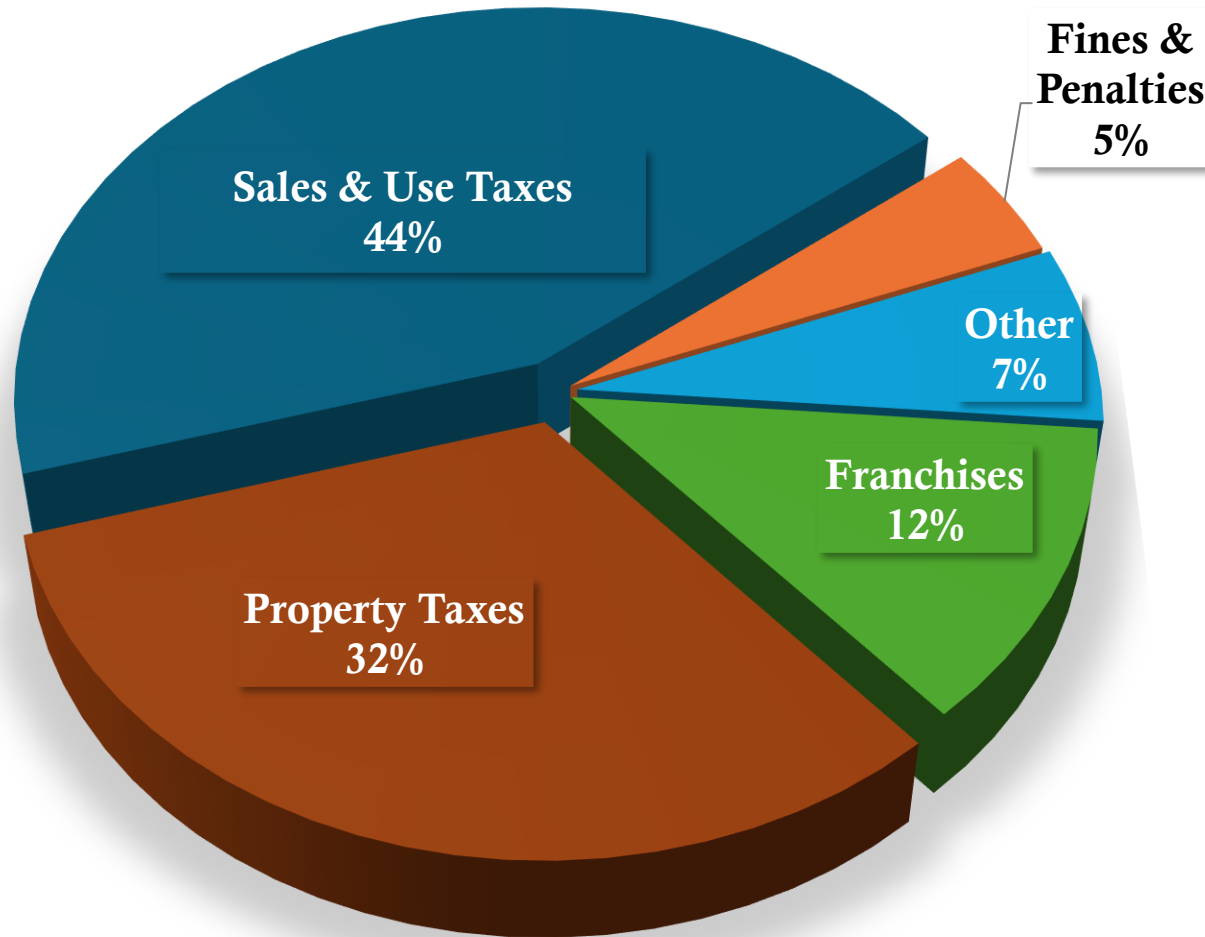

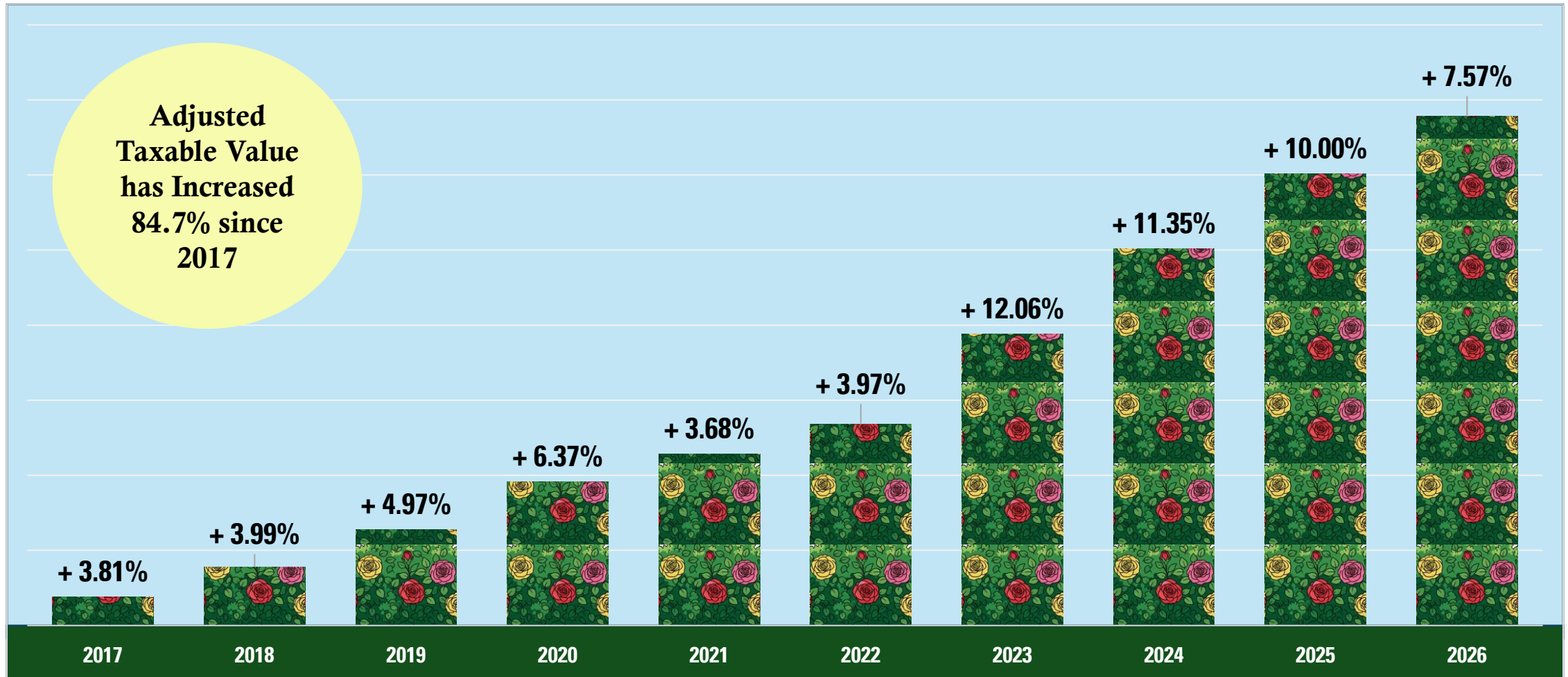

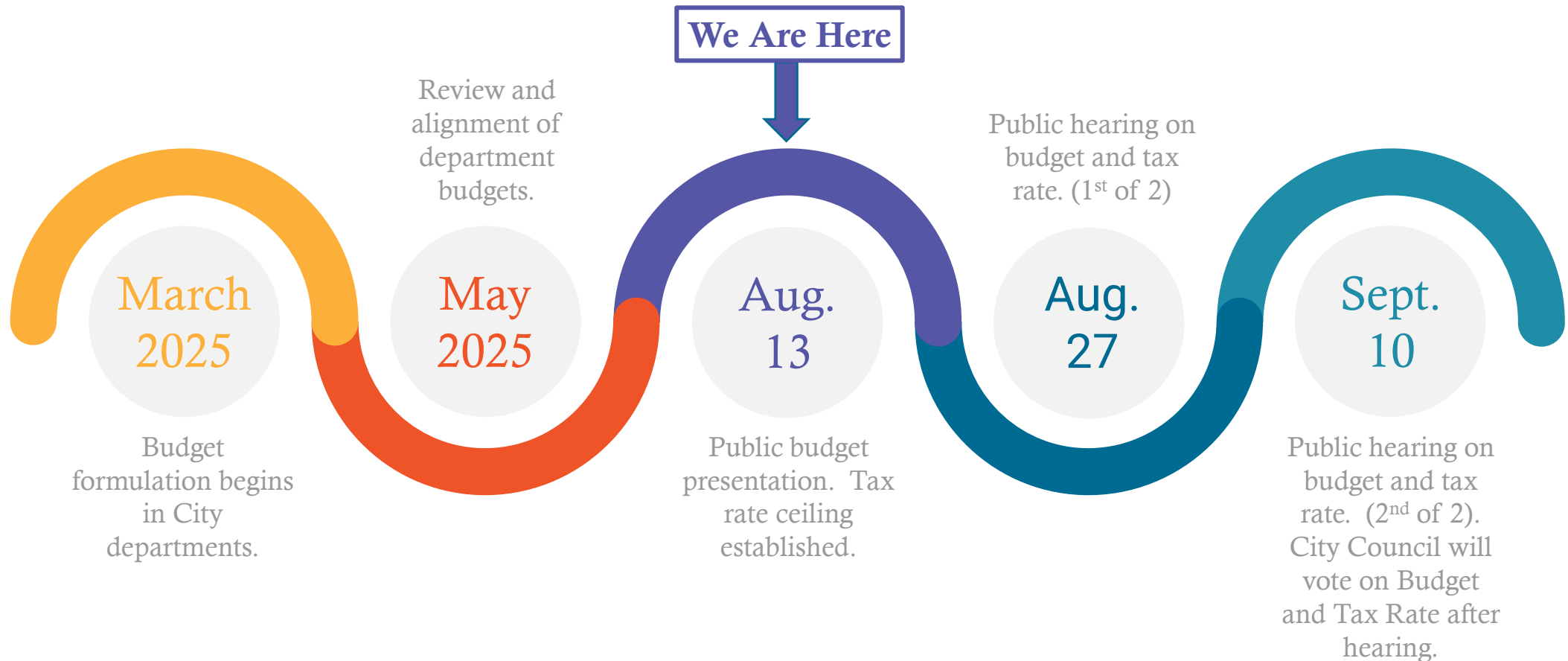

FISCAL YEAR 2025-2026 BUDGET TIMELINE

Below is a quick overview of the City of Tyler budget process.

The dates for our public meetings are included below. Both hearings and the adoption of the budget and tax rate will occur during the regularly scheduled City Council meetings on those dates. Those meetings occur on the 2nd and 4th Wednesday of every month. They are held in the City Council chambers at City Hall (located at 212 N. Bonner Ave.) and begin at 9 a.m.



RECOMMENDED ACTIONS:

1. It is recommended that the City Council vote to schedule public hearings on the proposed property tax rate and the proposed budget on the agendas for the August 27, 2025 and September 10, 2025 City Council meetings.
 2. It is recommended that the City Council vote to place proposals to adopt the property tax rate of \$0._____ and adopt the final fiscal year 2025-2026 budget as action items for the September 10, 2025 City Council meeting.
