

RESOLUTION NO. R-2024-42

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, AUTHORIZING THE APPLICATION FOR THE TEXAS DEPARTMENT OF TRANSPORTATION (TxDOT) GRANT FUNDS FOR PUBLIC TRANSPORTATION SERVICE FOR TYLER TRANSIT; AUTHORIZING ACCEPTANCE OF STATE URBAN GRANT STATE-U-2024-TYLER-00112 ALONG WITH ANY GRANT AMENDMENTS TO INCREASE THE GRANT FUNDING LEVELS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on June 27, 2024, the City of Tyler was notified by the Texas Department of Transportation (TxDOT) to make an application requesting \$405,774 for public transportation assistance for Tyler Transit; and

WHEREAS, the Texas Department of Transportation has stated that a Grant offer totaling \$405,774 should be made; and

WHEREAS, it is necessary for the City Council to authorize the submission of the application for TxDOT funds, as well as acceptance of TxDOT Grant State-U-2024-00112 and any grant amendments to increase the grant funding levels along with; and

WHEREAS, this grant supplies reimbursement for a portion of Transit Department operating costs. The remaining funds come from the adopted budget, departmental revenue, and State grant funds. If the City of Tyler did not receive this grant, the City would be responsible for all operating expenses; and

WHEREAS, it is considered to be in the public interest to obtain and use grant funds for the above public purposes;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

PART 1: That the Application for TxDOT Assistance for TxDOT Grant State-U-2024-00112 requesting \$405,774 for public transportation assistance for Tyler Transit, including all understandings and assurances contained therein, is hereby authorized and approved.

PART 2: That the City Manager's filing of the grant application, and all actions taken in connection therewith, is hereby affirmed.

PART 3: That the City Council hereby resolves and affirms to TxDOT that the City of Tyler has the legal authority to apply for the grant and to finance and carry out the proposed project.

PART 4: That the City Council hereby resolves and affirms to TxDOT the City of Tyler's intent to comply with all of the assurances set forth in the grant agreement and all laws, regulations, and circulars incorporated by reference in the grant agreement.


PART 5: That the City Manager is hereby authorized and directed to accept the grant for TxDOT Grant State-U-2024-00112 and any grant amendments to increase the funding levels.

PART 6: That the City Manager is hereby authorized and directed to take all actions necessary in order to accept and use the grant to fulfill the purposes described above.

PART 7: That the City Manager is hereby authorized and directed to provide such additional information as may be required by TxDOT.

PART 8: That this Resolution shall take effect immediately upon its adoption.
