

1. Work is approved in City of Tyler ROW only. Work in TxDOT ROW must be approved by TxDOT. Work within the Railroad must be approved by UPRR.
2. Permit is good for 90 calendar days.
3. A copy of your Insurance Certificate is required.
4. There may be water and sanitary sewer utilities throughout the proposed work area. Please use caution and contact the Water Service Center at (903) 531-1285 at least 48 hours prior to beginning work to locate water and sewer lines. If you have problems with water or sanitary sewer lines after normal business hours, on weekends or on holidays, please call the emergency number at (903) 531-6541.
5. There may be storm sewer utilities throughout the proposed work area. Please use caution and contact the Street and Drainage Department at (903) 531-1393 at least 48 hours prior to beginning work to locate storm sewer lines.
6. Any damage to public or private facilities must be repaired within 30 days.
7. If you plan to close any lane of traffic or an entire street, please also complete a separate Temporary Street and Lane Closure application, which is available for download at the City of Tyler Police Department website, and submit the completed application to the Tyler Police Department.
8. No traffic lanes will be closed between the following hours: 7:00 am to 8:30 am and 4:00 pm to 6:00 pm.


