C-A-5 Request that the City Council consider authorizing the City Manager to purchase two commercial frontload trucks from East Texas Mack through TIPS Contract 230802 for a total purchase price of \$351,820.

C-A-6 Request that the City Council consider ratifying staff action, authorization and execution for Amendment No.1 to Halff Associates, Inc. Work Order No. 1 in an amount not to exceed \$18,065.00 to provide additional services for the 2022 Highway Safety Improvement Projects.

Such purchases are being made through Board Cooperative Purchasing Contracts for the Tyler Fire Department, FY 25-26.

C-A-10 Request that the City Council consider authorizing the City Manager to ratify the Final Reconciliatory contract change order to B-C Company, Inc., for the Federal Aviation Administration FAA Grant 55 - Airfield Electrical Vault Replacement project, increasing \$48,280.00 to \$1,508,985.96, at Tyler Pounds Regional Airport.

C-A-11 Request that the City Council consider authorizing the City Manager to execute a new lease for a 20-year period from October 1, 2025, through September 30, 2045, for a Fixed Base Operator Lease for Johnson Aviation, Inc., at Tyler Pounds Regional Airport.

C-A-12 Request that the City Council consider authorizing the City Manager to approve a reconciliation change order that will decrease the contract amount by \$467,048.25 and the release of final retainage in the amount of \$158,678.19 to Texas Pride Utilities for the Consent Decree Group 4 Mainline Specialty CIPP.

C-A-13 Request that the City Council consider authorizing the City Manager to execute a contract with Kitching & Co, LLC in the amount of \$1,383,873.70 for the Consent Decree Group 7 Sanitary Sewer Manhole Package Bid 25-085 and to adopt a Resolution reserving the right to reimburse expenditures with proceeds of future debt. **(R-2025-55)**

C-A-14 Request that the City Council consider authorizing the City Manager to execute a contract with King Solutions Services, LLC in the amount of \$2,315,219.00 for the Consent Decree Group 7 Sanitary Sewer Mainline Package Bid 25-084 and to adopt a Resolution reserving the right to reimburse expenditures with proceeds of future debt. **(R-2025-56)**

C-A-15 Request that the City Council consider adoption of a Resolution denying Oncor Electric Company's requested increase to its system-wide transmission and distribution rates within the City and finding that the City's reasonable rate case expenses shall be reimbursed by the Company. **(R-2025-57)**

C-A-16 Request that the City Council consider authorizing the City Manager to execute the Reconciliation Change Order with Baker and Company Construction, LLC for the West Mud Creek Stream Restoration project, Bid No. 24-036, decreasing the approved contract amount by \$145,603.11, from \$3,388,043.00 to \$3,242,439.89, and approve the release of retainage.

CITY MANAGER'S REPORT

1. The Tyler Rose Garden is an official member of the American Public Gardens Association.
2. The City of Tyler welcomed a group from our sister city, Jelenia Góra, Poland, on Wednesday, Oct. 15. The group was greeted at City Hall by Mayor Don Warren, members of the City Council, and City Hall staff for a tour and gift exchange celebrating more than 30 years of friendship between the two cities. During their first day in town, the delegates toured Fire Station 1 and Faulkner Park, learning about the City's public safety operations and park facilities. The delegation's time in Tyler included experiencing the Texas Rose Festival, Tyler Rose Garden, and other local attractions that showcase the City's culture, hospitality, and community pride.
3. The leak at the Golden Road water treatment plant is fixed and back online. The Lake Palestine Water Treatment Plant (LPWTP) is back online, producing water at a reduced rate with 4 of 8 filters operational. We appreciate the community's cooperation in adjusting the irrigation schedule.
