Honoring Historical Achievements in Tyler and Smith County, Texas

Background

The Half Mile of History is a cultural and historic landmark program paying tribute to people, places and events that have contributed to the City of Tyler and/or Smith County. The Half Mile of History will tell the story of the rich history of Tyler and Smith County to present-day and future citizens.

Description

The Half Mile of History is a permanent, outdoor walk-around loop that covers an approximate one-half-mile stretch of sidewalk surrounding the square in the heart of downtown Tyler.

People, places and events chosen for the Half Mile of History will be honored with a commemorative plaque placed in the sidewalk within the designated area. Those selected for inclusion and placement of the plaques will be at the sole discretion of the City of Tyler with recommendation by the City of Tyler Historical Preservation Board.

Selection Criteria and Process

Nominations must involve outstanding contributions to the City of Tyler or Smith County. Possible areas to be considered are (but not limited to):

The major contribution(s) must have been made no fewer than 25 years ago.

Nominated individuals must be deceased and from Smith County or individuals who have spent a significant amount of time in Smith County.

A Judging Committee comprised of members of the City of Tyler Historical Preservation Board will make final selections based on how the nominee's contributions have an enduring impact on the community, county, region, the nation and/or the world. Recommendation for inclusion in the Half Mile of History will then be made to the City of Tyler City Council, which will have right to approval or disapproval of the nomination.

Nominations for inclusion in the Half Mile of History will be considered at the end of each quarter of the calendar year. Submissions must be made on or before the last business day of the quarter in order to be considered for inclusion in that quarter's nomination evaluation process.

The Judging Committee will consider the information contained within this application and the two additional pages. Additional materials will be used solely to assist in verifying the nomination of those selected for the Half Mile of History. Sources of any claims or statements should be included to facilitate the evaluation by the Judging Committee.

Induction ceremonies will be held at a time and date to be announced by the Historical Preservation Board.

SECTION C: Narrative

Tyler Civic Theatre Center, Inc. was incorporated as a State and Federal non-profit organization in 1949. TCTC is approaching its 65th consecutive season of providing outstanding amateur plays and musicals to “Entertain, Enrich and Educate through Theatre”. The incorporation coincided with the building of a 130 seat Theatre at 400 Rose Park Drive. The driving force behind the designing of a theatre in the round was Alfred Gilliam, who at that time was the Director of the Circle Theatre at Tyler Junior College. He and Mildred Stringer sketched out a “square” or round theatre, with a floor stage and elevated seats on all four sides, thereby allowing attendees an up-close and personal interaction with the performers. In 1951, the first theatre in the United States designed solely in-the-round opened with Alfred Gilliam as the first Director of Tyler Civic Theatre Center. A position he held until his death in 1988.

The Theatre is acknowledged as the first and longest continually operated “Theatre-in-the-Round” in the United States. In 2002, with the addition of the Braithwaite Theatre, the original theatre was renamed as the “Rogers Children’s Theatre” in memory of Tyler philanthropist Robert M. Rogers. It continues to this day to be used on a daily basis for the theatrical education of children and young adults, as well as for performances featuring actors in their age groupings.

Over the past sixty-four years Tyler Civic Theatre Center has averaged six major productions per year to an estimated audience of 50,000 individuals. The Board of Directors, the actors and the crew are volunteers who give of their time, talent and treasures to allow TCTC to provide Tyler, Smith County and east Texas the finest theatre experience possible.

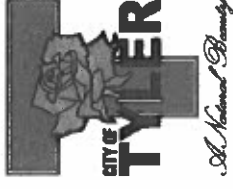
Half Mile of History

The goal of the Half Mile of History is to pay tribute to people, places and events that have contributed to the rich history of Tyler and Smith County.

The Half Mile of History is a permanent, outdoor, half-mile loop that surrounds the square in the heart of downtown Tyler. Stone plaques are placed in the sidewalk along the Half Mile of History to commemorate significant people, places or events.

Tyler Civic Theatre Center is approaching its 65th consecutive season of providing outstanding amateur plays and musicals to "Entertain, Enrich and Educate through Theatre." The incorporation coincided with the building of a 130-seat theatre at 400 Rose Park Drive. The driving force behind designing a theatre-in-the-round was Alfred Gilliam, who at that time was the *director of the Circle Theatre at Tyler Junior College.*

Over the past 64 years, the Tyler Civic Theatre Center has averaged six major productions per year to an estimated audience of 50,000 individuals.

Thomas Bonner was born in Mississippi in 1838 and moved with his parents to Rusk, Texas, in February 1850.

He entered Confederate service in April 1862. After the war, Bonner farmed until 1866, and was admitted to the bar in 1867. In 1872, he moved to Tyler, where he entered the banking business with E. C. Williams.

Bonner represented Rusk County in the state legislature, and in 1876, he was elected to the legislature from Smith County. He was speaker of the House during the ensuing session. After a term in Austin, he returned to Tyler to organize another bank, Bonner & Bonner, where he served as president until his death in 1891.
