

**RESOLUTION NO. R-2019-16**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TYLER,  
TEXAS, IN A MAXIMUM PRINCIPAL AMOUNT OF \$6,265,000  
APPROVING THE ISSUANCE OF A TAX EXEMPT FINANCING BY  
THE CREEDMOOR EDUCATION FACILITIES CORPORATION FOR  
THE BENEFIT OF CUMBERLAND ACADEMY, WITH NO FINANCIAL  
OBLIGATION TO THE CITY OF TYLER; AND PROVIDING AN  
EFFECTIVE DATE.**

**WHEREAS**, the City of Creedmoor, Texas, pursuant to the provisions of Chapter 53 of the *Texas Education Code*, as amended (the "Act"), has approved and created the Creedmoor Education Facilities Corporation (the "Creedmoor Corporation") as a nonprofit corporation to exercise the powers enumerated and provided in the Act for and on behalf of the City of Creedmoor; and

**WHEREAS**, pursuant to the provisions of the Act, the Creedmoor Corporation may issue revenue bonds or other obligations to provide funds for any of its purposes including financing or refinancing costs to acquire, construct, enlarge, extend, repair, renovate, or otherwise improve "educational facilities" or "housing facilities" and "facilities incidental, subordinate or related thereto or appropriate in connection therewith" for educational institutions, including Cumberland Academy, a Texas nonprofit corporation and open enrollment charter school (the "School"), and regardless if such facilities are located within or without the city limits of the City of Creedmoor; and

**WHEREAS**, the School is requesting the Creedmoor Corporation to issue a tax exempt financing (the "Financing") for the benefit of the School; and

**WHEREAS**, the Financing shall be evidenced by a tax exempt note or other evidence of indebtedness; and

**WHEREAS**, the Financing shall be issued by the Creedmoor Education Facilities Corporation in an amount not to exceed \$6,265,000, with the proceeds of the financing to refinance a previous loan made to the School to construct the Cumberland Academy High School Sports Complex being comprised of an eight-lane track, Astroturf Lacrosse/soccer field, baseball field, batting cages, additional sports fields and a concession stand with storage area and restrooms, and to finance certain ancillary facilities related to the Sports Complex including, but not limited to lighting for the Sports Complex, all to be located at the High School campus at 7200 Paluxy Drive, Tyler, Texas 75703, with the School to be the owner and user of these facilities (all such items being financed or refinanced referred to as the "Project"); and

**WHEREAS**, the Financing will be payable solely from revenues derived by the Creedmoor Education Facilities Corporation from the School pursuant to provisions of a Loan Agreement between the Creedmoor Corporation, BTH Bank, N.A., and the School and other applicable documents being entered into by the Creedmoor Corporation in connection with the issuance of the Financing, **and the City of Tyler, Texas, will have no responsibility in any manner for the payment of the debt service requirements of the Financing**; and

**WHEREAS**, Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), requires the City Council of the City of Tyler or the Mayor of the City (as the "applicable elected representative" of the "Government unit" where the Project is located) to

approve the issuance of the Financing after a public hearing has been held as provided in the next paragraph; and

**WHEREAS**, on March 27, 2019, a public hearing was held by this City Council, with respect to the Financing and the related Project, and notice of such public hearing having been published in a newspaper of general circulation in the City of Tyler at least 14 days prior to such public hearing; and

**WHEREAS**, the documents authorizing issuance of the Financing shall contain wording stating that the Financing imposes no liability on the City of Tyler, its officials, officers, or employees; and

**WHEREAS**, it is hereby deemed necessary and advisable that this Resolution be adopted;

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:**

**PART 1:** That all of the recitals and preambles hereinabove stated are found to be true and correct and are incorporated herein and made a part of this Resolution.

**PART 2:** That in order to satisfy the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended, and the requirements of the Act, the City of Tyler hereby approves the issuance of the Financing described above in an aggregate maximum principal amount not to exceed \$6,265,000 in order to obtain funds for the School to refinance the construction loan for the Project and to pay for certain further improvements of the Project. Proceeds of the Financing may also be used for paying certain expenses in connection with the issuance of the Financing, all pursuant to the requirements of the Act and other applicable laws.


**PART 3: THAT THIS APPROVAL IN NO EVENT SHALL MAKE THE CITY OF TYLER LIABLE IN ANY MANNER WHATSOEVER WITH REGARD TO THE REFINANCING OR FINANCING OR WITH REGARD TO THE PROJECT TO BE REFINANCED OR FINANCED WITH THE PROCEEDS OF THE FINANCING.**

**PART 4: THAT THIS APPROVAL IS GIVEN FOR THE LIMITED PURPOSE OF SATISFYING ANY REQUIREMENTS OF THE ACT AND SECTION 147(F) OF THE CODE, AND THIS APPROVAL DOES NOT APPLY TO ANY OTHER LEGAL REQUIREMENTS APPLICABLE TO THE PROJECT, INCLUDING BUT NOT LIMITED TO BUILDING CODE LAWS OR ZONING LAWS.**

**PART 5:** That it is hereby officially found and determined that the meeting at which this Resolution is passed is open to the public as required by law, and that public notice of the time, place and purpose of said meeting was given as required by law.

**PART 6:** That this Resolution shall become effective immediately upon its adoption.
