

**RESOLUTION NO. R-2019-3**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, INDICATING SUPPORT FOR THE APPLICATION OF TYLER ABBINGTON GRANDE, L.P., AN AFFORDABLE RENTAL HOUSING DEVELOPMENT KNOWN AS ABBINGTON GRANDE TO THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS FOR THE 2019 COMPETITIVE NINE-PERCENT HOUSING TAX CREDITS, APPROVING A WAIVER OF DEVELOPMENT /PERMIT FEES IN THE AMOUNT OF \$500.00, AUTHORIZING THE MAYOR AND/OR DESIGNATED CITY STAFF TO TAKE ALL NECESSARY OR APPROPRIATE ACTIONS ASSOCIATED THEREWITH; AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, it is the intent of the City Council to promote the general public welfare;  
and

**WHEREAS**, it is the intent of the City Council to promote and encourage affordable housing; and

**WHEREAS**, Tyler Abbington Grande, L.P. has proposed the construction of the development of affordable rental housing known as Abbington Grande located on Crow Road, approximately 700' west of Oak Hill Boulevard, in the City of Tyler, Smith County, Texas; and

**WHEREAS**, Tyler Abbington Grande, L.P. has communicated that it intends to submit an application to the Texas Department of Housing and Community Affairs for 2019 Housing Tax Credits for the Abbington Grande development; and

**WHEREAS**, Tyler Abbington Grande, L.P. has requested a waiver of development/permit fees in the amount of \$500.00 for the Abbington Grande development as a commitment of development funding from the City of Tyler, Texas; and

**WHEREAS**, as noted in Tyler City Code Section 1-9, the City Council has the authority to refund, transfer or waive any fee when, in its sole discretion, it determines that circumstances justify such action in order to promote a public purpose or the public welfare; and

**WHEREAS**, The City of Tyler, Texas has the authority to defer development fees on the property located on Crow Road, approximately 700' west of Oak Hill Boulevard;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TYLER TEXAS:**


**Part 1:** That the City of Tyler, acting through its governing body, hereby confirms that it supports the proposed Abbington Grande proposed to be located on Crow Road, approximately 700' west of Oak Hill Boulevard and that this formal action has been taken to put on record the opinion expressed by the City of Tyler on January 23, 2019.

**Part 2:** That the City Council, as governing body of the City of Tyler, Texas, hereby adopts this Resolution as evidence to its commitment of funds in the amount of \$500.00 to be provided to the development in the form of a waiver of development /permit fees.

**Part 3:** That for and on behalf of the governing body, Martin Heines, Mayor, and/or designated City Staff, is hereby authorized, empowered and directed to certify these resolutions to the Texas Department of Housing Community Affairs and to take all other necessary or appropriate steps or actions associated with this development funding.

**Part 4:** That this Resolution shall be effective immediately upon adoption.
