

**RESOLUTION NO. R-2018-14**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, AUTHORIZING THE CITY MANAGER OR DESIGNEE ON BEHALF OF THE TYLER FIRE DEPARTMENT TO APPLY FOR, ACCEPT, AND/OR TO TAKE ALL NECESSARY ACTIONS RELATING TO STATE GRANT FUNDING FROM THE OFFICE OF THE GOVERNOR IN THE AMOUNT OF \$20,646.05 TO FUND THE INTEROPERABLE COMMUNICATIONS FOR REGIONAL COMMAND TRAILER/TEAM; DESIGNATING THE CITY MANAGER OR DESIGNEE AS THE CITY'S AUTHORIZED OFFICIAL; AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, it is the intent of the City Council to protect the public health, safety and welfare; and

**WHEREAS**, the Office of Texas Governor has announced availability of grant funding that could be used toward the Interoperable Communications for Regional Command Trailer/Team; and

**WHEREAS**, the City Council of the City of Tyler finds it is in the best interest of the citizens of Tyler that the established State Grant Funding be utilized; and

**WHEREAS**, the City Council agrees that in the event of loss or misuse of the Office of the Governor funds, the City Council assures that the funds will be returned to the Office of the Governor in full; and

**WHEREAS**, that if the project is funded, the City of Tyler will comply with all grant requirements; and

**WHEREAS**, the grant funds will be used only for the purposes for which they are intended under the grant; and

**WHEREAS**, the City Council hereby designates the Tyler City Manager or Designee as the grantee's authorized official. The authorized official is hereby given the power to apply for, accept, reject, alter or terminate Grant/App. 3547501, to accept any increases in grant funding, and/or to take all actions needed to receive and expend grant funds and to act on all matters related to the grant, on behalf of the City of Tyler;


**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS;**

**PART 1:** That the City Council of the City of Tyler hereby approves the acceptance of State Grant funding through the Office of the Governor, Grnat/App. 3547501, in the amount of \$20,646.05 to assist in funding of the Interoperable Communications for Regional Command Trailer/Team for the Tyler Fire Department.

**PART 2:** That the City Manager or Designee is hereby designated as the City of Tyler's authorized official, and is hereby authorized to apply for, accept, reject, alter or terminate the grant, to accept any increases in grant funding, and/or take all necessary actions needed to receive and expend grant funds and to act on all matters related to the grant, on behalf of the City of Tyler;

**PART 3:** That this Resolution shall take effect immediately upon its adoption.
