

**ORDINANCE NO. O-2019-34**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, CANVASSING THE RESULTS OF AN ELECTION HELD ON THE 4<sup>th</sup> DAY OF MAY, 2019, FOR CITY COUNCILMEMBER DISTRICT NO. 3; AFFIRMING THE CANCELLATION OF THE ELECTION FOR CITY COUNCILMEMBER DISTRICTS NO. 1 AND 5; DESIGNATING THE UNOPPOSED CANDIDATES AS THE WINNERS FOR CITY COUNCILMEMBER DISTRICTS NO. 1 AND NO. 5, DECLARING THE RESULTS, AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, on the 15<sup>th</sup> day of May, 2019, the City Council of the City of Tyler, Texas, at a meeting duly called for the purpose, canvassed the returns of the City Council Election held on the 4<sup>th</sup> day of May, 2019, in the City of Tyler, for the election of the City Councilmember for District No. 3; and it appearing as a result of such canvass that the following named persons received the following number of votes for City Councilmember, District No. 3:

**District No. 3, For City Councilmember**

<b>Dalila Reynoso</b>	<b>135 Votes (24.86%)</b>
<b>Shirley J. McKellar</b>	<b>235 Votes (43.28%)</b>
<b>Pamela Phoenix</b>	<b>173 Votes (31.86%)</b>

**WHEREAS**, the City Clerk has certified in writing that the candidates for District No. 1 and District No. 5 were unopposed and that no write-in candidates had filed to be placed on the list of write-in candidates for that place; and

**WHEREAS**, Texas Election Code Sections 2.051 through 2.054 authorize the City Council to declare the unopposed candidates elected to office and cancel the unneeded elections; and

**WHEREAS**, on March 6, 2019, the City Council adopted Ordinance No. 0-2019-22, cancelling the Regular Election scheduled for City Council Districts 1 and 5 for May 4, 2019, and declaring the unopposed candidates elected to office;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:**

**PART 1:** That Linda Sellers be and is hereby declared the duly elected City Councilmember for District No. 1, to serve for a two-year term of office.

**PART 2:** That Bob Westbrook be and is hereby declared the duly elected City Councilmember for District No. 5, to serve for a two-year term of office.

**PART 3:** That the City Council Election for District No. 1, and District No. 5, scheduled for May 4, 2019, was cancelled by Ordinance No. 0-2019-22 and the unopposed candidates declared the winners, and such cancellation and declarations are hereby affirmed

**PART 4:** That the above named City Councilmembers for Districts No. 1 and District No. 5 shall be sworn into office and shall each serve for a two-year term of office.

**PART 5:** That this ordinance shall take effect immediately upon its adoption.
