Request that the City Council consider adoption of an Ordinance amending Tyler City Code Chapter 3 by amending the Civil Service Classification Plan and number of authorized Civil Service positions for Fiscal Year 2020-2021, by reducing the number of Fire Fighters by one and increasing the number of Fire Captains by one; and also reducing the number of Police Officers-Recruits by one and increasing the number of Police Lieutenants by one.
- V. Request that the Civil Service Commission consider amending the Tyler Firefighters’ and Police Officers’ Civil Service Commission Regulations by amending Rule 021 related to Firefighter examination requirements, Rule 022 related to physical requirements and examinations for Firefighters, Rule 023 related to eligibility requirements for Firefighters, and Rule 025 related to Entrance Examinations for Firefighters and Police Officers.
