**WHEREAS**, notice of City gatherings is regularly and routinely posted at least seventy-two (72) hours prior to the meeting in accordance with Texas Gov't Code Sec. 551.043; and

**WHEREAS**, notice for a gathering of the Tyler City Council was previously posted for the Tyler City Council to attend the Demolition Ceremony for Harvey Convention Center on Monday, August 2, 2021 at 11 a.m., located at 2000 W. Front St., Tyler, Texas; and

**WHEREAS**, due to weather, the City gathering originally scheduled for Monday, August 2, 2021 was delayed until Wednesday, August 4, 2021; and

**WHEREAS**, due to unforeseen circumstances, notice was not timely posted for the Tyler City Council gathering to be held at the Demolition Ceremony for Harvey Convention Center to be held on Wednesday, August 4, 2021, 1:30 p.m., at 2000 W. Front St., Tyler, Texas; and

**WHEREAS**, information was previously sent to persons planning to attend the Gathering; and

**WHEREAS**, it would create a severe hardship to persons planning to attend this event if the scheduled event was cancelled; and

**WHEREAS**, although this notice for a Council Gathering was not posted prior to 72 hours of the event it would result in unnecessary public inconvenience so there is an urgent public necessity that this posting be made and the Gathering proceed as originally planned and publicized; and

**WHEREAS**, Tex. Gov't Code Sec. 551.045 provides that when there is an urgent public necessity, the notice of a meeting or supplemental agenda item is sufficient if it is posted for at least one hour before the meeting is convened; and
