EMERGENCY NOTICE

WHEREAS, notice of City gatherings is regularly and routinely posted at least seventy-two (72) hours prior to the meeting in accordance with Texas Gov't Code Sec. 551.043; and

WHEREAS, due to unforeseen circumstances, notice was not timely posted for the East Texas Symphony In The Park on Saturday, September 3, 2022, at 7:00 p.m., located at Bergfeld Park, 1501 S. Broadway Ave., Tyler, Texas 75701; and

WHEREAS, information was previously sent to persons planning to attend the event; and

WHEREAS, it would create a severe hardship to persons planning to attend this gathering if the scheduled event was cancelled; and

WHEREAS, although this notice was not posted prior to 72 hours of the gathering, it would result in unnecessary public inconvenience so there is an urgent public necessity that this posting be made and that the event proceed as originally planned;

WHEREAS, Texas Gov't Code Sec. 551.045(a) provides that in an emergency or when there is an urgent public necessity, the notice of a meeting or the supplemental notice of a subject added as an item to the agenda for which notice has been posted in accordance with Tex. Gov't Code Chapter 551, Subchapter C. is sufficient if it is posted at least one (1) hour before the meeting is convened;

NOW, THEREFORE, pursuant to Texas Gov't Code Sec. 551.045, emergency notice for the East Texas Symphony In the Park on Saturday, September 3, 2022, at 7:00 p.m., located at Bergfeld Park,

1501 S. Broadway Ave., Tyler, Texas 75701, is hereby posted as follows:

The East Texas Symphony Orchestra (ETSO) is holding 2nd Annual ETSO Symphony in the Park at the Bergfeld Park. The concert is free and open to the public and features Richard Lee and the East Texas Symphony Orchestra, performing show tunes, popular classical, and patriotic, celebratory music and much more.

There is the possibility that a quorum of the Tyler City Council will be present at the ETSO Symphony in the Park on Saturday, September 3, 2022, beginning at 7:00 p.m. located at the Bergfeld Park 1501 S. Broadway Ave., Tyler, TX 75701.

Although some City-related items may be discussed, no action items will be considered by the Tyler City Council and no official action by the City Council is scheduled to be taken during this event.
