WHEREAS, Tex. Gov't Code Sec. 551.045(a) provides that in an emergency or when there is an urgent public necessity, the notice of a meeting or supplemental agenda item is sufficient if it is posted for at least one (1) hour before the meeting is convened; and

WHEREAS, information was previously sent to persons planning to attend this City Gathering; and

WHEREAS, it would create a severe hardship to the public and persons that planned the event if the scheduled event was cancelled;

NOW, THEREFORE, pursuant to Tex. Gov't Code Section 551.045, emergency notice of a City Council gathering is hereby posted as follows:
