EMERGENCY NOTICE

WHEREAS, notice of City gatherings is regularly and routinely posted at least seventy-two (72) hours prior to the meeting in accordance with Texas Gov't Code Sec. 551.043; and

WHEREAS, due to unforeseen circumstances, notice was not timely posted for the President's Holiday Celebration for invited guests on Friday, December 2, 2022, at 6:30 p.m., located at The Roger's Nursing and Health Sciences Center located at 1200 East Fifth Street, Tyler, Texas 75701; and

WHEREAS, information was previously sent to persons planning to attend the event; and

WHEREAS, it would create a severe hardship to persons planning to attend this gathering if the scheduled event was cancelled; and

WHEREAS, although this notice was not posted prior to 72 hours of the gathering, it would result in unnecessary public inconvenience so there is an urgent public necessity that this posting be made and that the event proceeds as originally planned;

WHEREAS, Texas Gov't Code Sec. 551.045(a) provides that in an emergency or when there is an

urgent public necessity, the notice of a meeting or the supplemental notice of a subject added as an item to the agenda for which notice has been posted in accordance with Tex. Gov't Code Chapter 551, Subchapter C. is sufficient if it is posted at least one (1) hour before the meeting is convened;

NOW, THEREFORE, pursuant to Texas Gov't Code Sec. 551.045, emergency notice for the President's Holiday Celebration for invited guests on Friday, December 2, 2022, at 6:30 p.m., located at The Roger's Nursing and Health Sciences Center located at 1200 East Fifth Street, Tyler, Texas 75701, for is hereby posted as follows:
