



Glass Men's Basketball League

- I. Entry Fee:**
 - a. \$300 per team
 - b. Cash, check or credit cards will be accepted. Make check payable to: **City of Tyler**
 - c. No refunds after the first game
- II. Procedure for registration**
 - a. Deadline to register will be Thursday, Feb. 20
 - b. All entries may be sent through the mail, over the phone or brought to the Glass Recreation Center
 - c. League begins Thursday, Mar. 2
 - d. Playoffs will be on Thursdays, date to be determine.
 - e. Team manager meeting will be on Feb. 23
- III. League Organization**
 - a. Game night is every Thursday nights (8 game season)
 - b. Time will be adjusted to fit league
 - c. Days are subject to change
 - d. All games will be played at Glass Recreation center, 501 W. 32nd St.
- IV. Rules**
 - a. Practice facility will not be provided
 - b. Two 20 min. halves
 - c. Two timeouts per periods, time outs can rollover
 - d. 5 minute rest time at half time
 - e. 5 minute grace period if you're late
 - f. Stop clock during last 2 minutes of game
 - g. Player **must provide** their own shirt/jersey and number on back
 - h. Jerseys are not allowed to be switched between players. (Possibly could keep up with each player's score)
 - i. Cannot pickup player on another team
 - j. Every player must check in at table with staff on duty
 - k. All players/teams must be able to play on Thursdays, if cannot, will be a forfeit, no changes to games after schedule is made
- V. Rosters**
 - a. No more than **10 players per team/roster**
 - b. No roster changes after second game
 - c. **Roster changes** allowed for a \$15 fee-if you need to add/drop a player for the remainder of the season, roster cannot exceed 10 players
 - d. **Substitution (Sub)**-is only allowed for an emergency and your team does not have enough players

VI. Awards

- a. 1st place receives trophy and shirts, 2nd place plaque and shirts

VII. Conduct

- 1. Coaches are responsible for their team
- 2. All players must check in before every game with staff on duty
- 3. **Zero tolerance for disrespect towards officials, coaches, players, and other spectators**
- 4. **Facility Code of conduct will be enforced, located inside facility to refer to.**
- 5. No refunds for disorderly conduct
