EMERGENCY NOTICE

WHEREAS, notice of City gatherings is regularly and routinely posted at least seventy-two (72) hours prior to the gathering in accordance with Texas Gov't Code Sec. 551.043; and

WHEREAS, due to unforeseen circumstances, notice was not timely posted for Arbor Day event on Saturday, January 21, 2023, at 10:00 a.m., located at Fun Forest Park 900 N. Glenwood Tyler, TX 75702; and

WHEREAS, information was previously sent to persons planning to attend the event; and

WHEREAS, it would create a severe hardship to persons planning to attend this gathering if the scheduled event was cancelled; and

WHEREAS, although this notice was not posted prior to 72 hours of the gathering, it would result in unnecessary public inconvenience so there is an urgent public necessity that this posting be made and that the event proceeds as originally planned;

WHEREAS, Texas Gov't Code Sec. 551.045(a) provides that in an emergency or when there is an urgent public necessity, the notice of a meeting or the supplemental notice of a subject added as an item to the agenda for which notice has been posted in accordance with Tex. Gov't Code Chapter 551, Subchapter C. is sufficient if it is posted at least one (1) hour before the meeting is convened;

NOW, THEREFORE, pursuant to Texas Gov't Code Sec. 551.045, emergency notice for Arbor

Day event on Saturday, January 21, 2023, at 10:00 a.m., located at Fun Forest Park 900 N. Glenwood Tyler, TX 75702, is hereby posted as follows:

The Tyler Trees Committee and the City of Tyler Urban Forestry Division will host a tree planting event to celebrate Arbor Day at Fun Forest Park. The event will start at 10 a.m. with a short ceremony, then volunteers will learn proper planting techniques, the value of trees and help plant 120 trees of a variety of species.

There is the possibility that a quorum of the Tyler City Council will be present at the Arbor Day event on Saturday, January 21, 2023, beginning at 10:00 a.m., located at Fun Forest Park 900 N. Glenwood Tyler, TX 75702.

Although some City-related items may be discussed, no action items will be considered by the Tyler City Council and no official action by the City Council is scheduled to be taken during this event.
