WHEREAS, notice of all City Council gatherings is regularly and routinely posted at least 72 hours prior to the gathering in accordance with Tex. Gov't Code Sec. 551.043; and

WHEREAS, due to unforeseen circumstances, notice was not timely posted for the Tyler Police Department Badge Pinning on Wednesday, February 15, 2022, at 3:00 p.m., located at Tyler Police Department located at 711 W. Ferguson St., Tyler, Texas 75702; and

WHEREAS, it would create a severe hardship to the public and persons that planned the event if the scheduled event was cancelled; and

WHEREAS, although this notice was not posted prior to 72 hours of the gathering, it would result in unnecessary public inconvenience so there is an urgent public necessity that this posting be made and that the event proceeds as originally planned;

WHEREAS, Texas Gov't Code Sec. 551.045(a) provides that in an emergency or when there is an urgent public necessity, the notice of a meeting or the supplemental notice of a subject added as an

item to the agenda for which notice has been posted in accordance with Tex. Gov't Code Chapter 551, Subchapter C. is sufficient if it is posted at least one (1) hour before the meeting is convened; and

NOW, THEREFORE, pursuant to Tex. Gov't Code Section 551.045, emergency notice of a City Council gathering is hereby posted as follows:
