**WHEREAS**, due to unforeseen circumstances, notice of this City Gathering was not posted at least 72 hours prior to the gathering; and

**WHEREAS**, information was previously sent to persons planning to attend the event; and

**WHEREAS**, it would create a severe hardship to persons planning to attend this gathering if the scheduled event was cancelled; and

**WHEREAS**, although this notice was not posted prior to 72 hours of the gathering, it would result in unnecessary public inconvenience so there is an urgent public necessity that this posting be made and that the event proceeds as originally planned;

**WHEREAS**, Texas Gov't Code Sec. 551.045(a) provides that in an emergency or when there is an urgent public necessity, the notice of a meeting or the supplemental notice of a subject added as an item to the agenda for which notice has been posted in accordance with Tex. Gov't Code Chapter 551, Subchapter C. is sufficient if it is posted at least one (1) hour before the meeting is convened;
